**Name of event:**

Get Lei'd 5k Run/Walk

**Description of event and course:**

Get Lei'd 5k Run/Walk is a Hawaiian themed 5k run/walk. Runners and walkers will enjoy a scenic route along the shores of Lake Michigan, receiving a Hawaiian lei and beach towel upon finishing the race.

The start and finish line will be at the North Beach Oasis. All festivities outside of the run/walk will remain on the North Beach Oasis area.

Runners will start at the North Beach Oasis. Head north on Lake Michigan Pathway. Follow the pathway all way behind the zoo and enter on to Michigan Blvd where they will utilize the parking lane. Runners will turn around on Michigan Blvd and head back south returning the exact same way they came. The finish line will be at the North Beach Oasis.

**Date/time of event (include set up/tear down dates/times):**

Saturday July 23, 2016. Run start 9:00 am. And conclude no later than 10:30 am.

We will be placing temporary directional markers and placing course marshals along the route to keep runners on the pathway. Markers will be removed by 10:30 am.

**Request for Approval:**

**Parking Lane Use:**

We are requesting the use of the east side parking lane along Michigan Blvd. from the exit of the Lake Michigan Pathway, just north of William Street, to Michigan Court. Runners will exit Lake Michigan Pathway on Michigan Blvd, use the parking lane going northbound, turnaround, and head southbound where they will re-enter Lake Michigan Pathway. Set up will begin at 8:30 a.m. and tear down will be complete by 10:30 a.m.

**Right of Way:**

With the exception of using the parking lane on Michigan Blvd., the run takes place on Lake Michigan Pathway and will not be crossing any streets. We are requesting the right of way of the east side parking lane along Michigan Blvd., between William Street and Melvin Street, to Michigan Court. Set up will begin at 8:30 a.m. and tear down will be complete by 10:30 a.m.

**Police presence:**

Please provide us information on the requirement or recommendation for police presence along Michigan Blvd. Set up will begin at 8:30 a.m. and tear down will be complete by 10:30 a.m.; however, runners will be on the course only between 9:00 a.m. and 10:00 a.m.

\*\*5Kevents.org will provide all traffic cones and no parking signs necessary for use of the parking lane. 5Kevents.org will also notify all neighboring business and residents of the event.
