PROGRAMS: Tobacco Control Community Coalition, Maternal and Child Health and Wisconsin Well Woman Program grants

REPORT FOR THE MONTH OF: November 2008

HIGHLIGHTS: The Wisconsin Well Woman Program covers the cost of an annual mammogram and Pap Smear for uninsured women who are age and income eligible. A new web based program management system was implemented by the State of Wisconsin on November 10, 2008 and it has several implications for the Wisconsin Well Woman Program (WWWP). This new management program is "Forward Health". The system that will control the management program is known as "Forward Health Interchange". As a result of this new system, the local coordinators (Racine included) have been part of several conference calls, short introductory trainings, as well as keeping our local providers aware of the many changes. This process is very new and has many flaws at the state level that need to be worked out. As a local coordinating agency we are working very had to make sure the women enrolled in the program continue to receive the same level of service as they had before.
