Subject: Communication from the Director of City Development submitting an Analysis of Impediments to Fair Housing Choice for the City of Racine. (Res No. 15-0122)

As a condition for receipt of community development funding from the U.S. Department of Housing and Urban Development, the City of Racine is required to affirmatively further fair housing. One means of doing so is to conduct periodically an Analysis of Impediments (AI) to Fair Housing Choice.

Subject: (Direct Referral) Request by the Director of City Development for authorization to execute a Memorandum of Understanding with the Institute for Community Alliances for services related to the Homeless Management Information System (HMIS). (Res No. 15-0123)

Recommendation of the Community Development Committee on 3-5-15: That the Memorandum of Understanding (MOU) with the Institute for Community Alliances (ICA) for the city's participation in the 2015 Homeless Management Information System be approved.

Further recommends that the appropriate city officials be authorized to execute the MOU with ICA.

Fiscal Note: The 2015 cost for ICA's services will be \$3,046.30. The cost will be paid from the Emergency Solutions Grant.

Director O'Connell explained that US HUD required that information regarding persons being served with Emergency Shelter Grant funds and similar HUD funding be reported in a common format. He said the Wisconsin grantees that receive HUD funds for homeless assistance had chosen the Institute for Community Alliances (ICA) to collect and report data for the Homeless Management Information System (HMIS). He further explained that this would be the second Memorandum of Understanding (MOU) with ICA and that ICA had provided high quality reports in a timely manner under the prior MOU.

A motion was made by Ald. DeHahn, seconded by Ald. Sarrazin, to recommend approval of the MOU with the Institute for Community Alliances. The motion PASSED by a Voice Vote.

Consolidated Plan: Preliminary 2015-2019 priorities and proposed funding allocation
