**Re: 2026-2027 Partisan Election Inspector Nominations and Appointments
Republican Party of Wisconsin and the Republican Party of Racine County**

Dear Ms. McMenamin and City Clerk Staff:

I represent the Republican National Lawyers Association and the Republican Party of Wisconsin (collectively, the “Republican Party”). On behalf of the Republican Party and its Racine County entity (the “RPRC”), I am writing to confirm that you have received the certified list of individuals affiliated with the Republican Party who shall be nominated and appointed as Election Inspectors in the City of Racine (the “RPRC List”).¹ The RPRC List is attached for reference and was submitted via e-mail earlier today along with a signed original that has been, or will be, timely mailed or delivered to your office.

Pursuant to Chapter 7 of the *Wisconsin Statutes*, as one of the two “dominant” political parties in the 2024 presidential election throughout the City’s polling places, you and your staff are required to present the complete RPRC List to the Mayor and ***the City Council shall appoint all such qualified individuals as Election Inspectors for the entire 2026-2027 Term prior to any unaffiliated nominees and subject to partisan balance requirements.*** *Wis. Stat. § 7.30, et seq.* Legitimate grounds for non-appointment of individuals on the RPRC List are very limited. If the names of any individuals listed on the RPRC List are not submitted or recommended for appointment, ***please promptly notify the RPRC and me of the name(s) of such individual(s) and the reason(s) for non-appointment so we may respond if necessary.***

The balance of partisan Election Inspectors is crucial to the proper administration of elections and essential to promote integrity and confidence in the outcomes. The Republican Party seeks to be a cooperative partner in these efforts but will also not hesitate to protect its rights and ensure compliance with the law, including the required appointment ***and scheduling*** of RPRC affiliated Election Inspectors. Thank you for your attention to this important matter and we look forward to a good working relationship and open communication leading up to and during the 2026-2027 elections.
