Approval of Minutes for the September 10, 2013 Meeting.

The minutes of the September 10, 2013 meeting were approved as printed. Passed unanimously.

Subject: Communication from Cheri Kulland, McKinley Middle School Directing Principal, requesting to close off the south sidewalk of Rupert Boulevard from Chicago Street west to the cemetery during the 2013-2014 winter.

Recommendation of the Public Works and Services Committee

on 9-24-13: That Racine Unified School District be granted permission to close the sidewalk on Rupert Boulevard fronting McKinley Middle School from December 1, 2013 to April 1, 2014 with the requirement that Racine Unified School District holds the City of Racine harmless from any and all injuries caused by conditions of the sidewalk related to this closure.

Fiscal Note: There will be no cost to the City of Racine in granting this permission.

Tom Eeg explained this was an annual request for McKinley Middle School to close off sidewalk on the south side of Rupert Blvd between Chicago St. and the cemetery property.

Mark Yehlen stated that closing all of College Avenue will also close the side streets which will create travel problems for eastbound and westbound traffic.

roadways.

Recommendation of the Public Works and Services Committee on 9-24-13: That the agreement with Precise Underground Marking Corporation to mark underground street lighting and traffic signal infrastructure, which ends December 31, 2013, be approved for a one (1) year extension with a per ticket price of:

Prescreens - \$9.55; Locates - \$12.21;

Site Visit/No Conflict - \$12.21;

Emergency During Business Hours (Clear/No Conflict/Site Visit/Locate) - \$12.21;

Emergency After Business Hours (Clear/No Conflict/Site Visit/Locate) - \$42.44;

Projects - \$26.52 per hour.

Fiscal Note: Funding to defray the cost of these services is available in Account 101.590.5610, Street Lighting-Professional Services.

Mark Yehlen stated this was the third (1) year extension of the contract with this being the first year that a rate increase was requested. He stated this rate increase was 3% and they have provided acceptable service to date.

Recommendation of the Public Works and Services Committee

on 9-24-13: That Contract 35-13 (K3-040), City Hall Renovations-Phase V (R1), be awarded to Triad Construction, Inc., West Allis, WI, at their base bid price of \$576,485.00, plus Alternate Bid #1 in the amount \$9,455.00, plus Alternate Bid #2 in the amount of \$15,366, plus Alternate Bid #5 in the amount of \$5,463.00, plus Alternate Bid #6 in the amount of \$716.00, for a total contract amount of \$607,485.00, they being the lowest responsible bidder.

Fiscal Note: Funding to defray the cost of this public works project be appropriated from Account 993.100.5010, City Hall-Facilities Plan.

Mark Yehlen recommended that the Base Bid and Alternate Bids No. 1, 2, 5 and 6 for a total contract amount of \$607,485.

Alderman Weidner questioned what the costs were for previous project areas. Tom Eeg stated that the Lower Level area was around \$725,000; the First Floor area was around \$670,000; the Second Floor area was around \$1,100,000 and the Restroom Renovations were around \$420,000.

Alderman Shield questioned if there would be any cost savings associated with the renovations. Tom Eeg stated that this would provide more efficient air handling control of the office areas and would provide more energy efficient lighting in these areas.

Alderman DeHahn questioned what the payback period would be for this renovation area. Mark Yehlen stated that we did cut 1 clerical position in 2013 with the intent to combine all these services at the new counter area covering Engineering, DPW and the Building Department. This would result in about a 10 year payback for this project.

Motion made by DeHahn, seconded by Kaplan to approve. On a roll call vote, members voting aye: DeHahn, Kaplan Members voting nay: Shields Motion passed: 2-1

Subject: (Direct Referral) Communication from the Commissioner of Public Works submitting bid results on Contract 56-13 (K3-060), Construct Home-1016 Park Avenue.

Recommendation of the Public Works and Services Committee on 9-24-13: That Contract 56-13 (K3-060), Construct Home-1016 Park Avenue, be awarded to Double D Construction, Inc., Kenosha, WI, at their bid price of \$217,352.00, they being the lowest responsible bidder.

Fiscal Note: Funding to defray the cost of this public works project be appropriated from Account 804.040.5310, 1016 Park Avenue Single Family Acquisition.

Mike Lechner stated funding is available to cover the cost of this construction project.

Alderman DeHahn asked how the project sites were determined. Mike Lechner stated that these are vacant properties that the City owns.

Alderman Weidner asked if all the green related products were specified on this project and why. Mike Lechner stated that green products were specified in this bid document and they create a more economical way to operate the site.

Alderman Shields asked how sites are selected for new construction. Mike Lechner stated that these are typically properties that Racine County obtained as a foreclosure property.

Motion made by DeHahn, seconded by Kaplan to approve. Passed unanimously.

Tom Eeg stated this Amendment would provide the final design services and construction administration of this project so it can be bid out early in 2014.

Fiscal Note: Funding to defray the cost of this change order be appropriated from Account 108.992.5010, Festival Hall Air Handlers.

Tom Eeg stated this Change Order would provide an energy efficient 2 speed motor control for the air handling unit that covers the entry and office areas at Festival Hall. Motion by DeHahn, seconded by Kaplan to approve. Passed unanimously.

Subject: Subject: Communication from the Assistant Commissioner of Public Works/Operations submitting Amendment No. 2 to the Recycle Cart Maintenance Agreement with Rehrig Pacific Company.

Recommendation of the Public Works and Services Committee on 9-24-13: That Amendment No. 2 to the Recycle Cart Maintenance Agreement with Rehrig Pacific Company, consultant, as submitted, be approved in the amount of \$200.00 per month.

Fiscal Note: Funding to defray the cost of these professional services be appropriated from Account 289.000.5610, Professional Services.

Tom Eeg stated this Amendment would provide a means to tie the Rehrig Cart Location database into the City's Tax Assessment database at a rate of \$200 per month. This would assist in generating the tax bills annually and eliminate the need to hire an outside agency to provide this service.
