Monday, October 17, 2022

Taste of Soul Bar and Grill - 501 Sixth St - Civil Trouble - A caller (neighbor) reported a large fight outside the bar. They reported a lot of yelling and screaming and that the fight was getting ugly. Another call came in for several gunshots heard. Police arrived and did locate broken glass, people associated with the fight and casings from gunshots. A short time later, a victim came into the hospital who had been shot while in the area of the fight. It appeared as though most of the people involved in the fight were inside of the bar at some point. As they left, the fight occurred. The bar was contacted and cooperated with allowing officers access to video. Unknown if the bar employees called police when the fight was happening. This is an on-going investigation. Update

The investigation into this incident is still on-going. From reviewing reports and witness accounts of this incident while the people involved may have been patrons of the bar, the physical altercation and subsequent shots fired occurred outside. Contact was made with the bar owner and the on duty bartender who were both at the scene. At the time of the initial fight outside they were inside the bar and became alerted of the incident when they heard the shots fired. The owner was cooperative with allowing officers and investigators into the bar and immediately providing video evidence of the incident which was crucial in identifying the suspect.

Police offered to take a report however while discussing the circumstances behind the money going missing the complainant decided he would handle the situation himself and ended the call.
