Subject: Communication from the Dorie Miller Post of the American Legion, 1234 Douglas Avenue, requesting a variance from the storm sewer requirements.

Keith Haas explained the grant program. He noted this is a federal program with oversite by the Wisconsin Emergency Management Department. There are several properties in the Lincoln Park area near Dominick Drive that had some problems with flooding in the past and this past June. He discussed some options to get funding to perhaps buy the properties and raze them and return the area to flood plain. Options the Utility had were to install a grinder pump to keep the home from being flooded with sanitary sewer when it overflows. There were some stipulations that need to be met with voluntary homeowners wanting to participate in the program and the structures need to be damaged more than 50% of the home value. There has to be a cost/benefit ratio exceeding one for the location to qualify for the program. This is informational only.
