Sgt. Rivers was present to discuss the report. He noted that Pepi's has had an uptick in the number of calls due to a neighbor who has complained about noise. There is no parking lot, so patrons tend to stand around on the street. The Club had an incident and arrest after patrons assaulted bar security. Bar security had denied entry to those patrons because The Club was at capacity. One of those patrons later returned with a gun, and a bar employee had been struck by a bullet. The following night, police assisted off-duty officers at Curmudgeon's and took this suspect into custody. Police learned of an incident at Rogers Bar, due to a patron receiving treatment at the hospital. The committee was concerned that Rogers Bar had not called in the incident, and requested that the owner appear at the next Public Safety and Licensing meeting. Alderman Kaprelian-Becker moved to receive and file the report, seconded by Alderman Sarrazin. Motion carried on a voice vote.
