Attorney Weber raised his concerns with the 3,000 square footage requirement and the number of employees as being viewed by the courts as discriminatory against small business owners. The percentage of wine sales vis-à-vis other alcohol would appear to be a valid criteria inasmuch as it applies to all establishments. There was a lot of discussion on this and some points included: what is required for set-up(would it be a fold up cart or what type of set up would be feasible and suitable); 1 year clearance from any violations and fee that would be implemented. Mr. Cameron and Shawn Voss both spoke on the item. The committee decided to defer the item and gather more information and bring it back at a future meeting.
