The General Manager explained that the Utility received an agreement from the Department of Transportation regarding plans for construction work on the Highway 20 Interchange and West/East Frontage Roads. He stated that the agreement is requesting relocation of three fire hydrants which are in the public right-of-way in order to accommodate this construction. He also stated that the agreement states that the Department of Transportation will pay an amount equal to 90% of the net cost incurred by the Utility for the relocation of these hydrants. The General Manager recommended that this agreement be approved and referred to the Finance and Personnel Committee for approval authorizing the Mayor and City Clerk to sign the agreement.

A motion was made by Thomas Friedel, seconded by James T. Spangenberg, that this be Recommended For Approval. The motion PASSED by a Voice Vote.
