<u>11-05-08</u> 13:48hrs. Dino's Italian Village – 1816 16th Street – Party believed to be fraudulently soliciting for charity. Officers found collecting was legitimate. 08-69467

<u>11-06-08</u> 18:16 hrs. Xpress Food Mart – 2418 Douglas Avenue – Clerk cited for underage cigarette sale during compliance check. Cooperative with Investigator. Found compliant when checked on 6-24-08. No previous violations this year. 08-69723

<u>11-06-08</u> 21:13 hrs. Double D Two – 1307 Douglas Avenue – Tavern owner complained of 26 y.o. female kicking at tavern door because she is not wanted in the tavern. Party warned and did not return. 08-69557

Joey's on 6th LLC – 910 Sixth Street – 31 y.o. male victim came to police on 11-14-08 at 11:48 hrs. and reported he was involved in pushing match inside Joey's on 6th on 11-6-08 with another male patron and was subsequently pushed by the patron, face first into a vending machine. Victim sustained two lacerations to his face. Victim's girlfriend immediately took him to hospital emergency care where the wounds required 37 sutures. Hospital did not call the police.
