The City Fleet Manager and the Purchasing Agent have reviewed these bids. We have determined that the bid offering the Mack LEU with the Loadmaster is the low responsive responsible bid. Please see memo from Mr. Nick Becker dated May 20, 2011 for additional detail regarding this purchase.

Recommendation: It is recommended that this bid be awarded to Kriete Group-Racine Truck Sales at their bid price of \$358,750.00 for two (2) Mack LEU with Loadmaster packer they being the low responsive, responsible bidder. It is further recommended that we accept their offer of \$13,000 for our trade-ins. The net outlay for this purchase will be \$345,750.00.

I have reviewed the Bidder's Proposals submitted for Official Notice # 6 a second time and have determined that the Loadmaster Excel-S packer complies to the overall length requirement of the specification. This was the primary reason for not recommending them originally.

The overall length requirement, as stated in the specifications, was increased from 31' in 2010 to 32' in 2011 to accommodate additional exhaust after-treatment systems. The new length was not updated in my refuse packer comparison worksheet and the Loadmaster appeared to not meet spec.

Therefore, it is my recommendation that we purchase the Mack LEU613 chassis with Loadmaster Excel-S refuse packers from Racine Truck Sales. The price for two complete units would be \$358,750. Trade values of \$13,000 were offered. The total acquisition cost would be \$345,750.
