to Approve changing the policy by adding the following sentence to paragraph 3: "Speakers and members of the audience should refrain from profane remarks, disruptive outbursts or other conduct which interferes with the orderly conduct of the meeting." and by creating paragraph 5: "The Mayor or presiding officer at his/her discretion may refer the individuals to staff for follow-up on any information presented. Speakers seeking an answer to a specific question should submit a written request to the Common Council by way of the City Clerk or their alderman."

Ald. Shakoor moved to approve the change in policy, seconded by Ald. Weidner, by amending the proposed last sentence of #3 to add the words "and members of the audience" after the word "speakers." The amendment passed 5 to 8, with Ald. Coe Abstaining, and Ald. Kaplan, Weidner and Shakoor voting against.

Ald. Sarrazin moved to remove the words "abusive or" in the proposed last sentence of #3 and to create paragraph 5 with language directing speakers with questions to the appropriate committees, seconded by Ald. Shields. The amendment passed 8 to 1, with Ald. Coe voting against.

Ald. Kaplan moved to adopt the amended policy, seconded by Ald. Weidner. The Motion passed 8 to 1, with Ald. Coe voting against.

A motion was made by Alderman Jim Kaplan, seconded by Alderman Sandy Weidner, that this be Recommended For Approval. The motion PASSED by a Voice Vote.
