Officers were dispatched in reference to a civil trouble. After speaking with bartender it was learned an argument occurred between two parties. A license premise check was completed and no violations observed.

The shooter then flees the scene in a vehicle.

Officer initiated a call for service to provide extra attention to this establishment. No issues were documented.

Unwanted party, called in by employee – Patron harassing other patrons and was escorted out of the bar. Problem party is now outside harassing people. Party left with a family member.

Fight, observed by officer – Officer on patrol observed a large crowd of people exiting the building as if there was some typo of discrepancy, so the officer stopped to give assistance. This officer then came in contact with the victim outside the bar and she stated she was struck with a closed fist by the father of her child, unprovoked while she was exiting the bar, causing her pain. Suspect then exited out the back door. Warrant recommendation submitted.
