Communication from the Alder of the 9th District requesting referral to Public Works and Services Committee his request asking that staff develop a proposal to ensure that Ordinance 18-529, as applicable to sump pumps and other drainage, is enforced in order to minimize clear water infiltration into sanitary sewers and the impact that it causes on basement backups.

Sec. 18-529. Clear water drains.

All clear water drains, including roof drains, surface drains, subsoil drains, refrigerator cooling water drains, air conditioning drains, and any other clear water drains not described in this section, shall discharge into a storm sewer wherever possible, but in no case shall such drains discharge into a sanitary sewer where no storm sewer is available. Where clear water drains are connected to existing sanitary sewers, the property owner shall, upon written notice from the commissioner of public works and/or wastewater utility commission or its manager, disconnect such clear water drains from the sanitary sewer.
