IN THE MATTER OF: Hearing on the Ethics Complaint filed by Wayne Clingman against Mary Jerger Osterman.

FINDINGS OF FACT

1. That, Mary Jerger Osterman was a member of the Racine Cable Commission at all times

between January 1, 2010 and May 5, 2014, and was also the owner / operator of the

Copacetic Hat Store, located at 409 Main Street, Racine, Wisconsin.

2. That, on or about February 4, 2014, Wayne Clingman, a member of the Racine Equality

Project, filed a notarized Complaint against Mary Jerger Osterman (hereinafter "Osterman"),

alleging that Osterman violated Sections 2-581(c) and 2-581(h) of the Racine City Code of

Ordinances when certain promotional pieces concerning Copacetic Hat Store were aired on

Belle TV, the City of Racine's local cable channel.

3. On March 18, 2014, the Racine Board of Ethics, pursuant to Section 2-584(c) determined

that there was probable cause to believe that Osterman was in violation of Sections 2-581(c)

and 2-581(h) of the Racine City Code of Ordinances and scheduled a hearing on May 5.

2014, pursuant to its authority in Section 2-584(c) (1)-(6) of the Code.

- 4. Notice of the Board's probable cause finding and Notice of Hearing were sent to Osterman
- on March 31, 2014.
- 5. On May 5, 2014, at a special meeting of the City of Racine Board of Ethics, Osterman

appeared with her attorney Thomas Devine, at which time the Board of Ethics commenced a

closed hearing pursuant to Section 2-584(c) (1)-(6) of the Code, and at which time counsel

for the Board presented evidence and examined witnesses under oath, as did counsel for

Osterman, said proceedings being recorded by a court reporter.

6. Following said hearing, the Board of Ethics deliberated with regard to the allegations

contained in the Complaint, and the Board made the following Findings of Fact, Conclusions

of Law and Recommendation:

a. The allegations contained in paragraphs 1-3 of the Complaint that

Osterman

violated Racine City Code of Ordinances Section 2-581(c), is not sustained by the

evidence.

b. The allegations contained in paragraphs 1, 2 and 7 of the Complaint that Osterman violated Section 2-581(h) of the Racine City Code of Ordinances. is not

sustained by the evidence.

CONCLUSIONS OF LAW

1. Osterman did not violate Section 2-581 (c) of the City of Racine Code of Ordinances related

to the offering or receiving of anything of value in a situation where it could reasonably be

expected to influence her vote, official action or judgment, or it could reasonably be

considered as a reward for her official action or inaction.

2. Osterman did not violate Section 2-581 (h) of the City of Racine Code of Ordinances related

to an official engaging in or accepting private employment or rendering services which

would conflict with the discharge of her official duties or would tend to impair her

independence or action or judgment in the performance of such duties.

RECOMMENDATION

*NOTE: The Board was concerned that both Osterman and other members of the Cable

Commission had unsuccessfully sought clarification of the local ordinance regarding advertising

and/or sponsorship from both City officials and representatives of Skies Fall prior to the pilot

project in question. The Board was also concerned by the fact that Osterman's business was the

first one to be promoted, but the Board ultimately determined that the purpose of the pilot project

was to promote economic development through the promotion of local businesses and not to

"advertise" Osterman's hat business. Although perhaps beyond its purview, the Board of Ethics

recommends amending the cable franchise ordinance to make it mirror Wisconsin state law and

to make it clear that advertising is permitted on our local channel.
