Fiscal Note: All costs will be provided for by the Mount Pleasant TID 5.

The General Manager noted that there is an Amendment No. 1 to the Retail Water Agreement with Mt. Pleasant. He explained that the amendment would provide assurance for monies being available to reimburse costs to allow the awarding of two water main contracts (W-18-3 and W-18-4). The General Manager recommended approval contingent upon DNR approval of the water mains.

1221-17 **Subject:** Ruekert-Mielke Amendment No. 1 to the Owner-Engineer Agreement for the Foxconn Project

Recommendation: Approve

The General Manager noted that he received Amendments No. 1 and No. 2 to the Owner-Engineer Agreement related to work for the Foxconn development project. These amendments include modifications to services to the Engineer and time for rendering services along with final design and bidding phases and construction-related services. He recommended approval of both amendments based on a percentage of overall project costs.

Subject: Authorize the General Manager to execute a license to occupy the public right of way

Recommendation: Approve

The General Manager explained that because of the work being done at Sturino Funeral Home on Northwestern Avenue, the Water Utility may need to access the public right of way to perform repair of the water main if needed in the future. He requested authorization to execute a license to occupy the public right of way with the assistance of the City Attorney.

1220-17 Subject: Bid Opening on Contract W-18-3, CTH H Transmission Water

Main

Recommendation: Approve

The General Manager submitted the bid results on Contract W-18-3 in the amount of \$5,348,511.00 and recommended approval to the lowest responsible bidder, that being Advance Construction, Inc. He noted that American Sewer Services, Inc. withdrew their bid due to a calculation error. He explained that the engineer, Kenneth Ward of Ruekert-Mielke, also discovered an error in the bid from James Peterson and Sons, Inc. and their bid was determined to be unresponsive. Therefore, because of these incidents, Advance Construction, Inc. is to be awarded the contract as the lowest responsible bidder.

Subject: Bid Opening on Contract W-18-4, I-94 Frontage Road Water Main

Recommendation: Approve

The General Manager submitted the bid results on Contract W-18-4 in the amount of \$1,973,340.00 and recommended approval to the lowest responsible bidder, that being DK Contractors, Inc. He noted that he received a letter from A.W. Oakes and Son, Inc. that questioned whether DK Contractors, Inc. was prequalified, but after further investigation by the General Manager, it was determined that they were properly prequalified in a timely manner per Utility past practice. The General Manager read the letter from A.W. Oakes aloud.

Subject: Private Lead Service Replacement Reimbursement Amount

Recommendation: Approve increasing the amount to \$3,000.00 per residential replacement

The General Manager explained that plumbing contractors have not been profitable with regard to the work they are doing with private lead service replacement. He stated that the State Grant reimburses private side residential lead service replacement and recommended increasing that amount to \$2,800.00, which was increased to \$3,000.00 upon further discussion.
