REPORT FOR THE MONTH OF: March, 2009

Highlights:

- A manuscript was submitted to the scientific journal *Water Research*. The content deals with the ability of real-time PCR to be utilized for monitoring water from a variety of aqueous sources (surface water, storm water, waste water).
- Root River samples continue to be collected twice per week; all but two of the storm water outfall sites are now
 accessible.
- Dr. Kinzelman completed her annual dairy license practical exam. Each certified analyst receives a series of unknown samples each year. The test results are compared to a series of referee labs receiving the same samples by the WI Department of Agriculture Trade and Consumer Protection.
- Our paper on the use of sanitary surveys to identify pollution sources and initiate remediation at our public bathing beaches has gone to press and will appear in the next issue of *Aquatic Ecosystem Health and Management*.
- Dr. Kinzelman has been invited by the US EPA to participate in a panel discussion as the individual representing local communities and public health at the national beaches conference. Each panelist will address a set question on their impressions of the state of the science (as presented at the conference) and how this compares to the current federal legislation being brought forward on Capitol Hill.
- Dr. Kinzelman, Stephan Kurdas, and AJ Koski gave presentations at the American Water Resources Association annual WI Chapter meeting in Steven Point, WI. Stephan Kurdas won the best undergraduate presentation for his poster on using a mathematical model to predict surface water quality at North Beach.
