Over the past few years I have been within parking tickets at several of the south side schools to include Fratt School. There are many parking problems at Fratt to include vehicles stopping/standing in the school bus areas, primarily on the east side of Fratt on Arthur Avenue.

The problem is that school starts at 7:38 a.m. and the parking signs are from 7:30 a.m. – 4:30 p.m. That allows me approximately 8 to 10 minutes of enforcement. Most of the parking issues with the school buses happen at around 7:20 a.m. I have also noticed that several new "No Parking" signs have been posted on the west side of Fratt and the signs state 7:00 a.m. to 4:00 p.m.

I am requesting that <u>all</u> signs around Fratt School, "No Stopping/Standing" on the east side be 7:00 a.m. to 4:00 p.m., "Loading Zone" signs on the west side be 7:00 a.m. to 4:00 p.m. and "Loading Zone" signs on Kinzie in the front of the school be 7:00 a.m. to 4:00 a.m. This will allow proper enforcement.
