Re: Harley-Davidson Lease Motorcycles

The current lease on the two motorcycles being used by the City of RacinePolice Department expires on July 1, 2011. We are submitting the new contract herewith.

The conditions of the vehicles: 1HD1FHM1977Y707287 and 1HD1FHM1X7Y707637 are outlined as follows.

- 1. Racine Harley-Davidson, Inc. will lease 2 (two) 2007 Harley-Davidson FLHP motorcycles to the City of Racine Police Department for \$1.00 each for the period of one year.
- 2. Vehicle warranty work will be provided by Racine Harley-Davidson, Inc.
- Vehicles may be used during off duty hours for promotional benefits and exposure to the City of Racine residents.
- 4. Vehicles to be insured by the City of Racine Police Department fleet insurance policy, and all damages incurred on the vehicles will be paid by the City of Racine Police Department.
- 5. Vehicles to be serviced and all expenses for maintenance to be paid by the City of Racine Police Department and done at Racine Harley-Davidson, Inc.
- 6. The cost of radios, extra lights, etc., will be paid by the City of Racine Police Department. The above items are to be affixed to the motorcycles in a manner that does no or minimal Cosmetic damage to the motorcycles.
- 7 The City of Racine Police Department agrees to hold Racine Harley-Davidson, Inc. completely harmless in connection with all aspects of liability in the use and operation of these leased vehicles.

- 8. The period of these leases will be one year, commencing upon July 1, 2011 or upon delivery to the City of Racine Police Department and expires on June 30, 2012. The renewal of this offer is at the sole discretion of Racine Harley-Davidson, Inc.
