Call To Order

The meeting was called to order at 5:30 p.m.

Approval of Minutes for the January 26, 2010 Meeting.

On a motion by DeHahn, seconded by Stein, the minutes were approved as printed.

1. <u>10-4666</u>

Subject: Communication from the Racine Yacht Club requesting permission to use city parking lots in conjunction with the U.S. National F-18 Catamaran Sailing Championships on August 6-13, 2010.

Recommendation of the Public Works and Services

Committee on 2-9-10: That the Racine Yacht Club be granted permission to utilize the parking area at the North Rooney Recreational Area and the city owned parking lot south of the eastern terminus of Barker Street, between August 6-13, 2010, for the U.S. National F-18 Catamaran Sailing Championships.

Further recommends that permission be granted with the following stipulations:

- A. A hold harmless agreement be executed:
- B. A liability insurance certificate be filed prior to this event.
- C. Any overtime costs incurred by any City department be charged to the sponsor;
- D. The sponsor shall notify all abutting property owners seventy-two (72) hours in advance of this event.

Further recommends that the Commissioner of Public Works/City Engineer and Chief of Police provide limited assistance, in the interest of public safety, to implement this event.

FISCAL NOTE: There will be nominal costs to various City departments, on a regular shift basis, to assist in implementing this event.

Rick read the request and noted there was a similar request for an event in 2006 and noted the approval could be made for the request subject to a hold harmless agreement and liability insurance being filed.

Recommendation of the Public Works and Services Committee on 12-8-09: That the item be referred to the Parks, Recreation and Cultural Services Commission with the request that the Parks Department maintain the sidewalk during winter months so that school children can use the sidewalk for access to Wadewitz and Gilmore Schools in an easier and safer fashion.

Recommendation of the Board of Parks, Recreation and Cultural Services 1-13-10: That the communication be referred back to the Public Works and Services Committee with the recommendation that the Parks, Recreation and Cultural Services Department not be responsible for clearing the snow.

Recommendation of the Public Works and Services Committee

on 2-9-10: That the Director of Parks. Recreation and Cultural Services be directed to maintain the sidewalk which abuts 2716 Northwestern Avenue, extending from Northwestern Avenue to Neptune Avenue, for the entire 12 months of every year.

Fiscal Note: There will be additional work by the City Parks Department on regular time to keep this sidewalk area free of ice and snow.

Ald. DeHahn noted the sidewalk should be kept open. Ald. Stein noted the Committee denied this request at a previous meeting. Rick noted the sidewalk has been closed by the Parks Dept. and it should be referred to the Parks Department to keep the sidewalk open and maintained.

On a motion by DeHahn, seconded by Stein, to direct the Parks Dept. to maintain the sidewalk during the winter.

Further recommends that the Commissioner of Public Works/City Engineer be authorized and directed to send a letter to the organizing agencies reminding them that if their event cannot be done in such a way that it meets all traffic rules and regulations and does not result in undue hardship to the abutting property owners, that they will need to request a special event permit for closure of certain streets.

Rick read the letter from Ald. Mozol. He noted the big question is whether or not the group uses the street, and, if they do use the street, were they closing it to traffic. He said if most groups are abiding by law and using the sidewalks and not impacting traffic, no permit should be needed and didn't feel the Public Works Office needed to regulate such events. A discussion ensued on whether groups of joggers or cross country teams from high schools running in groups would need to be permitted as well.

After further discussion, on a motion by DeHahn, seconded by Stein, the Committee moved to receive and file the communication and to send a letter to the organizers of the event indicating their responsibilities if they wished to use the street for this event in the future.

He noted by joining with SEWRPC and their effort for this work, it would greatly reduce the City's cost to have the ortho photos done, which would have been planned in 2011. Tom explained the three proposals received for architectural design services for the City Hall Facilities Plan, Phase III. He noted the cost of each of the proposals and recommended Butterfield, Rudie and Seitz for this work. Richard Christensen appeared before the Committee and believes the other firms are low bidding for this work in this tough economic environment and asked that the City consider his previous work on the City Hall renovation projects.

After further discussion a motion was made by DeHahn, seconded by Stein, to approve entering into an agreement with Butterfield, Rudie & Seitz.

Recommended For Acceptance as a Professional Services Agreement

Subject: (Direct Referral) Communication from the Assistant Commissioner of Public Works/Engineering submitting a proposed relocation order for storm sewer at 1921 Hickory Grove Avenue.

He noted obtaining an easement on the property would significantly reduce storm sewer costs on this assessable alley paving project. He noted if the easement was not procured, the storm sewer cost to build the alley would be significantly higher. He noted the City Attorneys Office would be working with the property owner.
