Ordinance No. 11-09

To amend Sec. 114-1033 of the Municipal Code of the City of Racine, Wisconsin relating to Sign regulations - Electronic message signs.

The Common Council of the City of Racine do ordain as follows:

Part 1:

Section 114-1033 of the Municipal Code of the City of Racine is hereby amended by adding the following at the beginning of the section:

"(a) Electronic Signs, (Educational Facilities)

For purposes of this section, Educational Facility shall be defined as a primary, secondary, or technical school (public, private, or parochial) involved in the instruction of students as its primary function. This definition shall not include community centers, religious institutions without a K-8th grade school, job training facilities, or other similar organizations providing student instruction.

(1) Standards

All electronic signage for educational facilities shall be constructed as set forth in this part and shall comply with the following standards:

a. Zone Districts

Allowed as a Conditional Use in any zone district in which the school is located.

b. Sign Area

- 1. One monument sign is allowed per site. The sign may have an electronic face on both sides of the sign.
- 2. The maximum size of the sign may not exceed 60 square feet, including borders, trim, etc. A maximum of 50% of the total sign area may be electronic.
- 3. Height may not exceed six (6) feet, as measured from average finished grade to the highest point on the sign cabinet.
- 4. The monument sign is allowed in addition to all other signage as allowed per Article X of the City of Racine Zoning Code.

c. Setback and Location

- 1. Minimum setback from any property line is 25'.
- 2. May not be located within 200' of a residential zone or use, and may not directly face a residential zone or use.

d. Electronic Message Restrictions

1. Messages are limited to advertisements of school activities and functions.

No commercial advertising is allowed.

- 2. The sign lighting may be on between the hours of 7:00 a.m. and 10:00 p.m., Monday through Friday.
- 3. Maximum of four (4) lines of electronic message are allowed per sign face. Lettering height will be determined by the posted speed limit on the adjacent street:
- (a). 0-30 mph: four (4) inches in height maximum
- (b). 31-45 mph: six (6) inches in height maximum
- (c). 46+ mph: ten (10) inches in height
- 4. The use of scrolling, flashing, blinking, chasing, traveling, or similar animation is prohibited.
- 5. Each message change shall be accomplished in one second or less, and each message shall remain in a fixed position for a minimum of sixty (60) seconds.
- 6. No additional electronic signage will be permitted in addition to, or in lieu of, an electronic monument sign.
- 7. No electronic monument signage shall interfere with or be in conflict with any traffic control devices. This shall be determined by the Commissioner of Public Works.

e. <u>Design Standards</u>

- 1. The sign design must be architecturally compatible with the school design, utilizing similar materials and established style as found in the principle structure.
- 2. A landscape plan shall be submitted as part of the Conditional Use. The landscaping shall address the area within six (6) feet of the sign, utilizing plantings that are complimentary to the sign base, appearance, and location of the sign. The landscape plan is subject to review and approval of the Director of City Development."

Part 2:

Amend 114-1033 by adding "(b) *Electronic Signs, (Non-Residential Uses)*" before the original paragraph, "Electronic message signs are allowed…"

Part 3:

This ordinance shall take effect upon passage and the day after publication.

Whereas, pursuant to and in accordance with the provisions of an Indenture of Trust dated as of March 1, 2004 (the "Original Indenture") between the City of Racine, Wisconsin (the "Issuer") and Wells Fargo Bank, National Association, as trustee (the "Trustee"), on April 1, 2004 the Issuer issued its Variable/Fixed Rate Demand Solid Waste Disposal Refunding Revenue Bonds (Republic Services, Inc. Project) Series 2004 in the aggregate principal amount of \$20,000,000 (the "Bonds"); and

Whereas, at the request of Republic Services, Inc., the Issuer desires to make certain amendments to the Original Indenture; and

Whereas, the Original Indenture authorizes the execution and delivery of a supplemental indenture to make such amendments.

Now, Therefore, Be It Resolved by the City of Racine, Wisconsin as follows:

1. Authorization of Execution Section and Delivery of Supplemental The Issuer does hereby authorize and approve the execution by the Mayor of the Issuer and the delivery of a First Supplemental Indenture of Trust (the "First Supplemental Indenture") between the Issuer and the Trustee, supplementing and amending the Original Indenture, and the Clerk of the Issuer is hereby authorized to attest to, and affix the official seal of the Issuer thereto. The First Supplemental Indenture shall be in substantially the form thereof attached hereto and marked "Exhibit A" and hereby approved, with such changes therein as shall be approved by the officers executing the same, with such execution to constitute conclusive evidence of such officers' approval and the Issuer's approval of any changes therein from the form of First Supplemental Indenture attached hereto.

Section 2. Authorization of Execution and Delivery of Related Tax Documents. The Issuer does hereby authorize and approve the execution

by any officer of the Issuer and the delivery of a new IRS Form 8038 for the Bonds and an amended Tax Exemption Certificate and Agreement among the Issuer, the Company and the Trustee.

Section 3. Authentication and Delivery of the Amended Bonds. The execution of the amended Bonds by the Mayor and the attestation by the City Clerk in accordance with the provisions of the First Supplemental Indenture is hereby authorized by the Issuer, and the Mayor or City Clerk of the Issuer shall deliver the amended Bonds to the Trustee for authentication in exchange for the existing Bonds, which shall be cancelled by the Trustee.

Section 4. Further Acts. The Mayor or City Clerk is authorized to sign all necessary documents on behalf of the Issuer to comply with the requirements of this Resolution and the First Supplemental Indenture.

Section 5. The execution and delivery of the First Supplemental Indenture by any officer of the Issuer as authorized in Section 1 above is expressly conditioned upon the following:

- a. the consent to the First Supplemental Indenture must be obtained from all necessary parties thereto; and
- b. the delivery of an Opinion of Counsel (as defined in the Original Indenture) that such amendments are authorized by the Original Indenture.

Section 6. Ratification of Acts.
