## 1) Police Department Women's Locker Room

Discussions with and Deputy Chief Mark Schulz and Kathy Kasper during the week of September 17 -21, developed into a request to modify the location(s) and number of the current showers within the Locker Room and possibly eliminate one toilet and also to eliminate the existing in-wall radiator unit, both to provide additional floor space for additional needed lockers; and the addition of a radiant heat ceiling panel. Design / plan development is near completion. Once a final decision is made by the RPD, design & specifications for modification of the Plumbing & Electrical systems will be required.

## 2) Safety Building Auditorium

Discussions with RPD Deputy Chief Mark Schulz, RFD Chief Steve Hansen, and other staff members September 17 -21, included requests and additional specifications for alterations & improvements to the Auditorium requiring modifications to the existing electrical system to provide requested capacity within the modified area for specific equipment, and to provide effective sound isolation & separation between the resulting 2 spaces, requiring specification of modification to the HVAC system above the ceiling. Design development is near completion. Once a final decision is made by the RPD and the RFD, design & specifications for modification of the HVAC and Electrical systems will be required.



To properly address these additional requirements, ARC proposes to engage the professional services of the two Consulting Engineering firms currently working on the City Hall Phase Four renovation project. Quotations attached.
