#### **Friday, May 1, 2026**

**Parlay on Main St** - 240 Main St - Officers were dispatched in reference to a noise complaint. Officers advised they could hear loud music as they were approaching Parlay. Bartender was advised and a license premise report was completed. **26-021416**
