Recommendation of the Public Safety and Licensing Committee on 8-22-11: To rescind the request to enter into an agreement with Coca-Cola, Inc. and enter into an agreement with Pepsi-Cola General Bottlers, Inc. to be the exclusive provider of beverages at the community centers.

Fiscal Note: Approximately \$41,000.00 over five years.

Donnie Snow appeared and informed the committee he had previously come before them requesting to enter into an agreement with Pepsi. He stated that the recommendation of some of the alderman was to seek other vendors in which they did. He stated the Purchasing Agent had made contact with Coca Cola company and had a verbal agreement, but was never able to obtain a signed agreement. In conversation with the Coca Cola Company, it was determined that the person who gave the verbal agreement had no authority to do this. He was requesting to rescind the request with Coca Cola, Inc. Director Snow was asking that the committee approve the recommendation to enter into an agreement with Pepsi -Cola General Bottlers, Inc. to be the exclusive provider of beverages at the community centers.

Alderman Helding requested that a e-mail from the Purchasing Agent be sent to all committee members explaining in detail what led up to this situation.

He stated his hours of operation would be 7:00a.m - 2:00p.m. with the exception of Packer Games, First Fridays and special events. Alderman Mozol questioned this and stated he preferred to see the hours of operation amended. After further discussion, it was determined that Mr. Roberts will submit to the Clerk's Office an amendment to his hours of operation before September 2, 2011.

Ald. Helding clarified that based on the business plan provided, the expectation is that this location will be a restaurant, not a tavern or club. If the licensee wants to change their business model, they should come back to this committee and request such changes."

He stated that municipalities would need to post signs to not allow people to carry them in City buildings. After further discussion, Alderman Helding withdrew his motion.
