### **Saturday, June 13, 2026**

**Taste of Soul Bar and Grill** - 501 Sixth St - Officers were dispatched in reference to several people hanging outside the bar. Officers dispersed the crowd and a license premise report was completed. No violations observed at this time. **26-029765**

### **Sunday, June 14, 2026**

**Pub on Wisconsin** - 525 Wisconsin Ave - Officers observed what they believed to be a disturbance outside the bar. Parties were dispersed. A license premise report was completed with no violations observed. **26-029987**
