**Sunday, August 10, 2025**

**Doobies Beer Joint** - 3701 Durand Ave - extra attention - Officers conducted extra attention and did not observe any violations. **25-035277**

**Pub on Wisconsin** - 525 Wisconsin Ave - Assault Report - Officers were dispatched to Racine PD Lobby in reference to an assault that took place at Pub on Wisconsin. Officers advised a female was assaulted by two other females while inside the bar. Video was obtained from a bystander and viewed by officers. Two females were located and arrested in reference to this incident. Officers made contact with bartender who was unable to work the camera system. At the time of this report, Officers have been assigned to do a follow up for a license premise report. **25-035281**
