INTERGOVERNMENTAL AGREEMENT – FIRING RANGE SERVICES

Village of Mount Pleasant / City of Racine

This Agreement effective this ____ day of _____, 2013, between the **VILLAGE OF MOUNT PLEASANT** (“Village”) and the **CITY OF RACINE** (“City”), both municipal corporations of Racine County, Wisconsin, collectively called the “Parties” herein.

WHEREAS, the City maintains a police department within its jurisdiction, whose officers are required by State law and internal policies, to satisfactorily complete range training on a periodic basis; and

WHEREAS, the Village is completing a firing range and training building at its Village headquarters; and

WHEREAS, the City is desirous of utilizing the range training facility on an ongoing basis and is willing to fund the costs of construction up to the amount of One Hundred Fifty Thousand Dollars (\$150,000.00); and

WHEREAS, Wis. Stat. § 66.0301 authorizes cooperating between municipalities for the furnishing of required services; and

WHEREAS, by Resolution, the Parties have authorized the payment and use of said facility.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the Parties agree as follows:

- A. The Village agrees to provide the range training facility and services as described in Exhibit A, which is attached hereto and incorporated herein by reference as though fully set forth herein.
- B. The City agrees to make a contribution payment for the facility and services provided hereunder in the amount and under the terms and conditions referenced above.
- C. The Parties agree that this Agreement shall bind City and Village and their respective successors by operation of law, but shall not be otherwise assignable by either without prior written consent of the other.
