## Approval of Minutes for the September 19, 2016 Meeting

**Subject:** Communication from the Alderman of the 13th District, on behalf of Liz Martin (1919 Deane Blvd) requesting a four-way stop at the intersection of 19th Street and Deane Boulevard.

Recommendation of the Traffic Commission on 09-19-16: Defer

## Recommendation of the Traffic Commission on 11-21-16:

Recommends that stop signs be reversed at the intersections of Deane Boulevard and 19th Street.

**Fiscal Note:** The estimated cost of this signage will result in an installation cost of \$200.00 and an annual maintenance cost of \$80.00.

Liz Martin appeared before the Traffic Commission and explained her concerns regarding some accidents and near misses at the intersection of 19th Street and Deane Boulevard.

Secretary Rooney noted a study was done after the completion of 21st Street reconstruction project from Taylor Avenue to Grove Avenue. This was done so no

detour traffic would be going through the area. He noted that four accidents took place over a five-year period. None of them were correctable by traffic control. He did note the approaches being stopped in the east-west direction have four times the traffic volume as the approaches going north-south. He recommended reversal of the stop signs at this location to stop the minor volume of traffic and let the major volume of traffic go through.

After further discussion, a motion was made by Yehlen, seconded by Weitzel to approve reversal of the stop signs. Passed unanimously.

**Subject:** Communication from the Alderwoman of the 6th District, on behalf of Janet Mrazek (2520 West High Street), requesting a No Parking area near the West High Street roundabout area.

## Recommendation of the Traffic Commission on 11-21-16: Defer

Alderwoman Weidner appeared before the Traffic Commission and expressed concerns of parking on the south side of the West High Street approach into the new roundabout at Northwestern Avenue. She believes parking on the south side will create hazard to traffic trying to enter the roundabout. She cited several locations where a van and trailer being parked there seems to create a problem, particularly with parking too far from the curb. She recommended removal of parking all the way to Orange Street.

Secretary Rooney noted that in his opinion, removing parking on West High Street up to the splitter island from Orange Street is not necessary. He noted parking is allowed on both sides of West High Street all the way to Jefferson Street. He noted the width of West High Street into the roundabout is the exact same width of the original West High Street that went into Northwestern Avenue at a more conventional type intersection. He felt there was no hazard to driving this approach into the roundabout. He commented that on-street parking for those on the south side of the street would cease to exist with approval of no parking.

Alderwoman Weidner asked the Traffic Commission members to look at it for themselves and asked that the item be deferred.

Motion made by Weitzel, seconded by Heckenlively to defer. Passed unanimously.
