

Dear Ms. Lesniak:

The Home Hazardous Waste Surcharge is not legally binding because of the following:

- 1. Under lack of performance it is not enforceable.
- 2. It lacks a provision for not being in use and on line to the customer.
- 3. It violates the customer's legal entitlement of the Racine Water and Waste Water Utilities fiduciary obligation to fulfill a performance prior to requesting reward of a payment.
- 4. No proper notice of a surcharge was given to the customer prior to the initial surcharge request of payment.
- 5. No interest shall be attached to a surcharge without legal merit.
- 6. All previous and existing Water and Waste Water Utilities have been paid in full. See attached.

It is requested that you SHOW CAUSE by legal documentation to the customer as to the legal merit of this surcharge enforcement.
