He thought for busy days/events perhaps there could be shuttles to the beach. Discussion was held regarding extra Police enforcement. Ald. Subject: Communication from the President of the Racine Raider AlumniAssociation wishing to discuss the details of a new structure at Horlick Athletic Field to house the Racine Pro, Semi-Pro Minor League Historical Museum.

Snow said that staff did meet with the Raiders regarding their proposal. It was thought that the best place for the museum would be in the parking lot to make it more available even when events were not going on.

Bob Milkie appeared and said that the museum would cover an era from 1896 to the present. The facility would be run by the Raiders. The museum would impact 12 parking spaces.

Stein moved and it was seconded by Wisneski to approve in concept. Further recommend that detailed plans and specifications and site location be worked through with the PRCS staff and that the PRCS Board be kept informed of the progress.

Subject: Communication from the Co-Race Director of the Jingle Bell Run for Arthritis Racine 2008 requesting permission to use City right-of-way on Saturday, December 6, 2008. (Res.08-1048)

Recommendation of the Public Works and Services Committee on 10-14-08: Jingle Bell Run for Arthritis be granted permission to close Island Park Drive from Liberty Street to Rupert Boulevard, Horlick Park Drive from Rupert Boulevard to 12th Street, and Domanik Drive from Spring Street to Jefferson Street for the Jingle Bell Run/Walk for Arthritis, to be held on Saturday, December 6, 2008, from 9:00 a.m. to 10:30 a.m., with the following stipulations:

- A. A hold harmless agreement be executed.
- B. A liability insurance certificate be filed prior to this event.
- C. Any overtime costs incurred by any City department be charged to the sponsor.
- D. The sponsor shall notify all abutting property owners seventy-two (72) hours in advance of this event.
- E. The sponsor shall pay a special event fee of \$300.00.

Further recommends that the Commissioner of Public Works/City Engineer and Chief of Police provide limited assistance, in the interest of public safety, to implement this event

Fiscal Note: There will be nominal costs to various City departments, on a regular shift basis, to assist in implementing this event.

Tom Rudey appeared and gave a history of the event. He said the Racine event has always been one of the top events in the state.

Wisneski moved and Dyess seconded the motion to grant permission to the Jingle Bell Run for Arthritis-Racine Event to use Island Park Drive south from the pavilion to the bridge, Horlick Park Drive from the intersection of Horlick Park Drive, Island Park Drive and Rupert Blvd. to the intersection of Horlick Park Drive and 12th Street, the pedestrian pathway north from the bridge to and under Spring Street, the Pedestrian Pathway through Brose Park, the Pedestrian Pathway north of Lincoln Park Drive from the bridge over the Root River to the bottom of the hill, the Pedestrian Pathway north of the Steelhead facility leading over the bridge into Colonial Park, the Pedestrian Pathway through Colonial Park to bridge leading to West High Street, and back through the above areas to the parking lot behind Lutheran High School for the Jingle Bell Walk/Run on Saturday, December 6, 2008 from 9:00 a.m. to 10:30 a.m. with the following stipulations.

- A. a hold harmless agreement be executed
- B. a liability insurance certificate be filed prior to this event
- C. any overtime costs incurred by the city departments be charged to the sponsor
- D. all abutting property owners be notified of this event 72 hours prior to this event.

Snow explained that the Friends of Seniors contract will expire May 2009. Other uses of the building include Animal Crackers and as a polling site. Dick Hinsman appeared and said the goal of Friends of Seniors (FOS) is to have a county-wide stand alone center. Hinsman did apologize for the recent commentary to the Journal Times written by someone. Hinsman said that other communities have established centers for seniors. FOS is asking for an extension of one year. Cal Converse spoke and said the senior activities at the community centers are not what they are looking for. Snow said that the contract was structured to give FOS the opportunity to look for a place of their choice. Further Snow said that the five community centers have senior programming that is fairly well attended. He said that while Kenosha has a center they do not have community centers. Eleanor McCarthy spoke and said that the FOS cleaned up the building when they started there. Charlie Clark said that he has gone to look at dozens of facilities

Wisneski moved and LeGath seconded the motion to defer. Passed unan.
