Recommendation of the Finance and Personnel Committee on 09-25-2023: That the Wastewater Commission be granted approval to authorize the issuance and sale of up to \$23,367,711 Wastewater Utility Revenue Bonds, series 2023b, and providing for other details and covenants with respect thereto.

Fiscal Note: The Wastewater Utility Revenue Bonds (Clean Water Fund Loan) is in the amount \$23,367,711. Loan is for 20 years and has an interest rate of 2.190% and (\$2,050,000) Principal Forgiveness.

The Wastewater Utility Director presented a Financial Assistance Agreement (FAA) resolution needed to close out on a Clean Water Fund Loan (CWFL) for the 2020 Facilities Improvements Plan. This FAA is comprised of two loans; one for engineering and the other for construction related costs. One of the loans will reimburse the Utility for expenditures related to the planning, design, bidding, parts of the air permit modifications, and contract execution of the following three projects: UV Disinfection, Engines/Blowers, and Biogas Conditioning. The other loan will fund the construction of all three projects. This FAA is the final step for the Utility to secure state funding with the City's backing.

Subject: Approval of Change Order No. 1 on Contract D-22 Biogas Conditioning Project, Lee Mechanical (contractor)
