AGENCY ROLES in the CoC CONSOLIDATED APPLICATION

United Way of Racine County is the fiscal agent.

Bethany Apartments (Catherine Marian Housing) is a provider of shelter specific to victims of domestic violence.

Center for Veterans Issues is a provider of shelter in the form of motel vouchers and this service is available to all eligible persons. It is not veteran specific.

Legal Action of Wisconsin is the provider of legal services for prevention, and the coordinated entry point for prevention services in the CoC.

Legal Action of Wisconsin is the provider of services to assist persons who are homeless to locate housing, negotiate leases and overcome barriers to renting permanent housing.

Racine Vocational Ministry is the provider of services targeted at employability to persons residing in shelter .

SAFE Haven is the provider of shelter to youth considered homeless.

Urban League of Racine and Kenosha is the provider of case management and rental assistance for prevention services.

Women's Resource Center is the provider of shelter to persons who are victims of domestic abuse.
