Subject: Communication from Chief of Police Wahlen requesting to use Federal law to allow qualified retired officers to carry concealed weapons. (Res. #08-0752)

Recommendation of the Finance & Personnel Committee on

04-07-08: Permission granted for the Chief of Police, pursuant to Federal Law Officers Safety Act of 2004 HR218, to allow retired police officers to carry concealed weapons after passing firearm qualifications and the Police Chief's approval and further recommends that the Finance Department create a separate account for the \$100 fee required from the retired officers.

Recommendation of the Public Safety and Licensing Committee on 4-7-08: That the request of Chief of Police Wahlen, to use the Federal law to allow qualified retired officers to carry concealed weapons, be approved.

Recommendation of the Public Safety and Licensing Committee on 4-21-08: That the Chief of Police be granted the authority to allow qualified retired officers to carry concealed weapons.

Fiscal Note: There will be no cost to the City.

Alderman Wisneski stated he was one of the co-sponsors for this resolution. He stated he felt this would help make the City safer as to who would be carrying concealed

weapons. He also commented on the training that those officers would have previously received.

Alderman Kaplan pointed out the tools and training are in place and he felt comfortable with the information provided. He would support the resolution.

Alderman Wisneski questioned Attorney Weber whether the Chief of Police would have the authority to deny the applicant.

Attorney Weber stated that it is at the discretion of the Chief. He also informed committee members that regardless of the committee's decision, HR218 is a Federal Law.

Alderman Wisneski made a motion to grant the Chief of Police permission to allow qualified retired officers to carry concealed weapons.

Alderman Wisneski amended his motion to include that a public hearing be scheduled before the Common Council on May 6, 2008.
