Monday, August 25, 2025

DOOBIES BEER JOINT - 3701 Durand Ave - Officers were dispatched to a different location in reference to an assault that took place at Doobies. Victim advised they were assaulted while inside the bar. Officers made contact with the bartender and advised it was only a verbal altercation while inside. A license premise report was completed and no violations observed.
