He stated with the new smoking ban, he is trying to maintain the same clientele, but would like to be able to offer them something else to continue to utilize his business. There are 4 additional part time employees and he will monitor the situation and determine if additional employees would be needed. One of the aldermen questioned whether or not underage would be allowed in a billiard hall. The owner stated that if he has 12 tables they are allowed and he currently has 11 and will be adding an additional table. The Police/Attorney's office will be checking into this to make sure they are following the State law related to this.

Alderman Maack also suggested they consider a scanning system as well as a camera system.
