Ordinance 03-15 - Amend Chapter 114

An ordinance to amend Chapter 114 of the Municipal Code of the City of Racine, Wisconsin as it relates to the massage establishments, dance studios and dance schools.

The Common Council of the City of Racine, Wisconsin, do ordain as follows:

<u>Part 1:</u> Repeal Sec. 114-447 (b) (25) of the Municipal Code of the City of Racine, Wisconsin and recreate it as follows:

"Massage establishments, as defined in Section 22-766, above the building's street level, or at the building's street level but no closer than 20 feet to the store front with therapy stations being screened from view."

<u>Part 2:</u> Repeal Sec. 114-447 (b) (42) of the Municipal Code of the City of Racine, Wisconsin and recreate it as follows:

"Dance studios or dance schools above the building's street level, or at

the building's street level but no closer than 20 feet to the store front with instruction and performance areas being screened from view."

<u>Part 3:</u> Repeal the word "dance" from Sec. 114-448 (16) of the Municipal Code of the City of Racine, Wisconsin.

<u>Part 4:</u> Repeal the word "dance," from Sec. 114-467 (b) (3) a. of the Municipal Code of the City of Racine, Wisconsin.

<u>Part 5:</u> Repeal Sec. 114-468 (14) of the Municipal Code of the City of Racine, Wisconsin and recreate it as follows:

"Physical fitness centers, including physical culture and health services gymnasiums."

<u>Part 6:</u> Repeal Sec. 114-468 (21) of the Municipal Code of the City of Racine, Wisconsin and renumber the subsequent subsections accordingly.

<u>Part 7:</u> In Sec. 114-487 (b) (23) of the Municipal Code of the City of Racine, Wisconsin, repeal the words "and massage".

<u>Part 8:</u> In Sec. 114-507 (b) (8) of the Municipal Code of the City of Racine, Wisconsin, repeal the words "massage salons".

<u>Part 9:</u> In Sec. 114-507 (b) (12) of the Municipal Code of the City of Racine, Wisconsin repeal the word ", dance".

<u>Part 10:</u> This ordinance shall take effect upon passage by a majority vote of the members-elect of the City Common Council and publication or posting as required by law.
