<u>Part 1</u>: Repeal subsections (a), (c), (d), (e), (f), (g), (h), (i), (j), (k), (l), (m), (n), (o), (p), (q), and (r) of Section 70-101. - Closing Hours of the Municipal Code of the City of Racine, Wisconsin.

<u>Part 2</u>: Renumber the current subsection (b) of Section 70-101. - Closing Hours of the Municipal Code of the City of Racine, Wisconsin to "(a)".

- <u>Part 3</u>: Create the following subsections in Section 70-101. Closing Hours of the Municipal Code of Racine, Wisconsin as follows:
- "(b) Park Closing Hours: Except for vehicular traffic moving upon or through streets or roadways through a park, except for scheduled sports leagues and community events, the parks and parkways shall be closed at 10:00 p.m. The parks will remain closed from said time until sunrise the following morning and no person shall remain therein during said hours.
- (c) The park closing prohibitions shall not apply to members of organizations and their families when such organizations have received approval of the common council to be on park grounds during

closed hours in a designated area on specific dates. Such approval shall be conditioned upon the City receiving from the organization a cash bond in an amount established by the Parks, Recreations and Cultural Services Board. Such a bond shall be forfeited by the organization to the extent required to repair or replace park property or facilities damaged by negligence or vandalism during the time of the organization's use of such park and facilities, notwithstanding the fact that such use may not be exclusive."

<u>Part 4</u>: This ordinance shall take effect upon passage by a majority vote of the members-elect of the City Common Council and publication or posting as required by law.

Ordinance adopting an amendment to a document titled "A Comprehensive Plan for the City of Racine: 2035" (Comprehensive Plan) to adopt and incorporate therein a document titled "Uptown Neighborhood Strategic Development Plan" (Uptown Plan).

The Common Council of the City of Racine do ordain as follows:

Part 1: Pursuant to Section 62.23 of the Wisconsin Statutes, the City of Racine is authorized to prepare and adopt certain amendments to the Comprehensive Plan as defined in Sections 66.1001(1)(a) and

66.1001(2) of the Wisconsin Statutes; and

Part 2: On January 14, 2015 the Plan Commission forwarded a recommendation to the Common Council that an ordnance be prepared, that a community open house before the Plan Commission be scheduled, that public hearing be before the Common Council be scheduled, and that a resolution and ordinance be prepared for an amendment to the Comprehensive Plan to effectuate the adoption and incorporation therein of a document titled "Uptown Neighborhood Strategic Development Plan" (Uptown Plan), and that the community open house be scheduled for February 25, 2015 and the public hearings before the Common Council be scheduled for March 3, 2015; and

<u>Part 3</u>: The Plan Commission of the City of Racine conducted a community open house on February 25, 2015 to solicit opinion and educate the public on a proposed amendment to Comprehensive Plan to adopt and incorporate therein the Uptown, and

<u>Part 4</u>: The Plan Commission of the City of Racine, on February 25, 2015 by a majority vote of the commission recorded in its official minutes, recommended to the City Common Council approval of a resolution and ordinance adopting and incorporating the Uptown Plan as an amendment to the Comp Plan; and

<u>Part 5</u>: The Common Council has duly noticed and conducted a public hearing on the amendment to Comprehensive Plan, in compliance with the requirements of Section 66.1001(4)(d) of the Wisconsin Statutes.

<u>Part 6</u>: The Common Council of the City of Racine, Wisconsin, does, by the enactment of this ordinance, formally amendment the document titled "A Comprehensive Plan for the City of Racine: 2035" to adopt and incorporate therein the document titled "Uptown Neighborhood Strategic Development Plan", pursuant to Section 62.23 and Section 66.1001(4)(c) of the Wisconsin Statutes.

<u>Part 7</u>: The design guidelines contained in the document titled "Uptown Improvement Plan, Racine Wisconsin" as adopted by the Common Council on May \_\_\_\_\_\_, 2005 and incorporated in Chapter 114 the Municipal Code of the City of Racine on July 5, 2005 through Ord. No. 11-05, shall remain in full force and effect, except where in conflict with the Uptown Plan as hereby adopted.

<u>Part 8</u>: This ordinance shall take effect upon passage by a majority vote of the members-elect of the City Common Council and publication or posting as required by law.
