I would like to submit the following communication for committee of the whole...

Communication from the alderman of the 15th district, requesting a meeting of the committee of the whole for the purposes of a) receiving an update on the progress of the bulky waste collection process and b) discuss a process for green waste collection.

Rationale re bulky waste: I have had constituents who have received letters stating that bags and boxes are not allowable as part of bulky waste collection. This makes a bit of a challenge for people who are moving/spring cleaning. So, I would like to clarify some of the specifics of the new bulky waste process.

Rationale re green waste: There was a previous request to discuss green waste collection process and I believe the items has not been scheduled to be in front of us.
