Thursday, November 9, 2023

 The Void-213 Sixth St- Unwanted Party- A named complainant (owner) called about a party outside the tavern causing a problem. Upon officers arrival they located the party who has had prior police contact. The party was arrested for an outstanding warrant and was also issued a citation for disorderly conduct.

Bucks Lounge- 963 ML King Dr- Battery- A refused complainant called about someone who had been stabbed. Upon officers arrival they located the victim outside the tavern. The victim was transported to Ascension Hospital for further medical treatment. It was learned the victim was inside the tavern and when they were leaving a known party came up to them asking for money. Sunday, November 12, 2023

Rogers- 1843 N. Wisconsin St- Fight- A named complainant (owner) called about a fight between two patrons. Once officers arrived they were **23-046456** informed by the owner the problem parties left and they were no longer needed. Call Received: 00:14 Arrived: 00:15

Sunday, November 19, 2023

The Void- 213 Sixth St- Unwanted Party- A named complainant (owner) called about unwanted parties inside the tavern. Upon officers arrival **23-047538** they spoke with the owner who informed the problem parties left and police were no longer needed. Call Received: 02:07 Arrived:02:07

Pub On Wisconsin- 525 Wisconsin Ave- Fight- A named complainant (bartender) called about a fight inside the tavern. Upon officers arrival no **23-047539** active fight was located. Officers spoke with the bartender and a security guard. It was learned that the security guard was attempting to get people to move out of the tavern when one of the patrons refused. A fight occurred between the security guard and the unknown patron until other employees were able to get the unknown patron out of the tavern. The investigation is on-going at this time. The Blue- 835 Washington Ave- Tavern Check- A refused complainant called about three underage patrons inside the tavern. Upon arrival officers did not locate anyone who matched the description given or who appeared to be underage. They also spoke with the owner about the complaint.

Sunday, November 26, 2023

Pub on Wisconsin- 525 Wisconsin Ave- Tavern Check- A refused complainant called about an underage person inside the tavern. Upon officers **23-048374** arrival they were able to locate the party inside the tavern and found them to be underage. When asked how they entered without a valid identification card they stated they "knows people". The party was escorted out of the tavern and cited for underage person on premises. The Sports Pub on Washington- 1301 Washington Ave- Fight- An officer was providing extra attention to the area when they observed people running from the tavern saying something about a fight. The officer then heard what sounded like chairs being thrown within the tavern. When officers entered the tavern they observed a patron using what appeared to be OC spray on another patron. The officers stated they were also sprayed with the OC spray during the altercation inside the tavern. In addition the patron that was sprayed appeared to be covered in blood as they were being taken out of the tavern by other patrons. Officers were unable to locate the patron covered in blood due to the chaotic scene. Once the scene was under control officers spoke with the bartender who stated they believe the altercation may have started in the bathroom but was unsure. Officers attempted to speak with other patrons around the tavern but none of them wished to speak with officers. The tavern then closed for the night. Call Received: 00:53
