**Subject:** Discussion of Preliminary Findings Related to Upcoming Water Rate Case - Jim Fiacco of Ruekert-Mielke invited to the meeting

The General Manager introduced James Fiacco of Ruekert-Mielke who discussed the 2009 rate case for the Water Utility. He noted that the reasons for the rate increase request were because the operation and maintenance expenses for the Utility have increased \$1.2 million since the 2007 rate case, the Water Plant assets have increased \$11.1 million since the 2007 rate case, and there has been a 6.9% decrease in water usage. He suggested doing a rate case every year in order to recover the debt on Utility projects.

**Subject:** Submittal of the Report of the Finance Committee of the Racine Waterworks Commission regarding year 2009 Water Utility Operation & Maintenance Budget and the 2009-2013 Capital Improvements Budget Recommending Adoption

Recommendation of the Racine Waterworks Commission of 9-30-08: To adopt. Refer to the Finance and Personnel Committee.

The General Manager noted that it was possible to reduce the Operation & Maintenance budget in order to make an impact on the upcoming Public Service Commission rate case and that the contractual services on the proposed Operation and Maintenance budget could be reduced by \$100,000.00 and the health insurance could also be decreased by \$260,000.00. By making these suggested reductions, it would have approximately a 2% impact on the pending rate case. These changes would also result in a change in the Operation & Maintenance budget from 2008 to 2009 of about a negative 0.9%

Commissioner DeMatthew made a motion, seconded by Commissioner Anderson, to adopt the 2009 Water Utility Operation and Maintenance budget. Furthermore, Commissioner Anderson made a motion, seconded by Commissioner Hart, to amend the proposed Operation and Maintenance budget to reduce health insurance to \$1.1 million and also reduce contractual services, specifically Wastewater Services, to \$900,000.00. Furthermore, to refer this item to the Finance and Personnel Committee for approval. The motion passed unanimously.

Commissioner DeMatthew made a motion, seconded by Commissioner Hart, to adopt the 2009-2013 Water Utility Capital Improvements budget. Furthermore, to refer this item to the Finance and Personnel Committee for approval. The motion passed unanimously.
