Looking through the minutes:

In 1978, No parking was approved on the east side and 1-hour parking on the west side between 8A-4P on M thru F, except holidays. This was in response to complaints employees and visitors to Lincoln Lutheran occupied the streets which prohibited sweeping, plowing, and the occasion emergency vehicle from using the street.

In 2001, the alderman of the district asked to have the parking restrictions removed to free up parking for the residents. Perhaps the use of Lincoln Lutheran changed at that time.

It appears that what is past is now prologue...

Unless I hear otherwise, I'll get this item on PW&SC as a DR from myself on behalf of the Alderman of 6th District for consideration of No Parking Anytime on Brooker Street , west side, from Harriet Street to Prospect Street.
