Ordinance No. 18-06 to amend Sec. 70-101 of the Municipal Code relating to Parks -Closing hours.

To amend Sec. 70-101(a) of the Municipal Code of the City of Racine, Wisconsin relating to Parks, Recreation and Cultural Services - Parks; Closing hours.

The Common Council of the City of Racine do ordain as follows:

Part 1:

Sec. 70-101(a) of the Municipal Code of the City of Racine is hereby amended by inserting after "law enforcement officers," the phrase, "city concession contractors and employees thereof for a period not more than 45 minutes after park closing but only while actively engaged in their work,".

Part 2:

This ordinance shall take effect upon passage and the day after publication.

Attorney Christy Hall appeared and spoke about the Ordinance amendment. Hall said the Oasis was suppose to have a 9:00 p.m. last call and be closed by 10:00 p.m. but there has been violations. Hall said she met with Donnie Snow and City Attorney Dan Wright. Further, she said she feels this amendment is a way to accommodate the concessionaire. Hall said this is a residential neighborhood and the residents are trying to be good neighbors. McCarthy asked if there is anyone working in this capacity at any other park. Snow said there was not. Snow said this Ordinance will stay unless it is amended. Mr. Curtin has said that he needs time to clean and restock the next day. Linda Sargent appeared and said that she feels this is more of a bar than a concession and that it is not for families but for drinking. Further she said there is a lot of broken glass on the beach. Helding said there is a restriction on glass bottles. John Sargent spoke and said he can not sit down to a quite dinner when the music is playing. Hall said the Police to respond when requested. Jim Rooney spoke as part of the Michigan Blvd. Association requesting the Board receive and file the amendment. Further, he said the residents have been coming to this Board for four years. Motion made by Weidner to receive and file amendment.

Snow summarized the result of the meeting he and Tom Molbeck had with Mr. Curtin. Ald. Kaplan commended the committee and audience for the way they dealt with this issue.
