Recommendation of the Redevelopment Authority on 1-16-14:

That the Authority supports the use of funding from the Intergovernmental Revenue Sharing Fund for the financial assistance for Altus Vinyl LLC.

Further that the Authority recommends that the financial assistance be conditioned upon Altus Vinyl LLC agreeing to expand in Racine, acquire and relocate to 1907 St. Patrick Street, and give preference to City of Racine residents when filling open positions.

Further that the Mayor and City Clerk be authorized and directed to execute a financial assistance agreement with Altus Vinyl LLC in substantially the same form as outlined in the Memorandum from RCEDC attached to this file.

RDA Resolution 14-01

Assistant Director Sadowski explained the request. Altus Vinyl LLC is looking to expand and relocate from its current location at 3801 S. Memorial Drive to 1907 St. Patrick Street.

Mr. Sadowski introduced Jenny Trick from the Racine County Economic Development Corporation (RCEDC) who further explained the background of the company. She explained that the company leases their current facility and is looking to purchase a facility. She stated Altus Vinyl LLC currently has 12 full-time employees and they are looking to expand that number.

Mr. Sadowski explained that assistance would come in the form of a tax reinvestment program with the business owner that would provide him with a yearly reimbursement of \$2,874.00 over a ten year period for the amount of jobs created, at \$1150.00 per job.

Commissioner Chambers asked about the average cost per job. Ms. Trick responded that \$7,000 per job has been the City's precedent.

Mr. Sadowski read the Resolution for the item.

A motion was made by Commissioner Lange, seconded by Commissioner Garner, to adopt RDA Resolution 14-01, recommending approval of the request. The motion PASSED by a Voice Vote.

Mr. Sadowski explained the request and stated that the item is similar to the previous request. Marlo Incorporated of Racine is looking to expand at its current location, 2227 South Street. Laura Million of RCEDC further explained the request and the history of the company. She stated the company would like to expand to provide more manufacturing and office space and has a plan of providing 43 new jobs over a three year period.

Subject: (Direct Referral) Review of a memorandum of understanding

between the City of Racine and Redevelopment Authority of the City of Racine for the status of the property at 1129 Michigan Boulevard (Harborside Property). (Res. No. 14-0043)

Recommendation of the Redevelopment Authority on 1-16-14:

That the City and the Redevelopment Authority enter into a Memorandum of Agreement for the maintenance, general oversight and eventual transfer of ownership from the City to the Redevelopment Authority for the Harborside Parcel, as outlined in the Memorandum of Understand document attached to this file.

Further, that the Mayor of the City and the Chairman of the Redevelopment Authority, and their representives as indicated in the attached Memorandum of Understanding document, be authorized and directed to execute said document for the maintenance, general oversight and eventual transfer of ownership of the Harborside Parcel.

Fiscal Note: Costs will be addressed through funds secured from the US EPA and WEDC, TID 14, Intergovernmental Shared Revenue Fund, Capital Improvement Budget, Redevelopment Activities account as part of the Department of City Development budget, and future efforts to attract additional funds from multiple sources.

RDA Resolution 14-03

Mr. Sadowski introduced item and the Memorandum of Understanding (MOU) that accompanied. He stated that under the MOU, the Redevelopment Authority would be responsible for maintenance and holding of the property. He explained that the property is currently owned by the City of Racine and that ownership would eventually be transferred to the Redevelopment Authority; City grant activities would have to first be completed before the property could be transferred to the Authority.

Mr. Sadowski stated that the MOU allows the Authority better flexibility in accessing the property which would allow for studies to take place and better coordination of certain events. Mr. Sadowski went over the basic points of the MOU.

Commissioner Andersen asked about the intent of the request.

Mr. Sadowski explained that the MOU would help streamline the process for conducting certain activities on the site and will give the Authority better access to the property.

Alderman Kaplan spoke regarding his concerns. He stated he would like the parking for the Fourth Fest and the Ironman events to remain.

Mr. Friedel spoke regarding the events. He explained that the greatest attempt would be made to; however the first priority is cleanup of the site. He also stated that the transfer of responsibility and pending ownership would have been accomplished many years ago but, back then, development proposals were being entertained and it was thought the transfer of the property into private ownership was imminent.
