**1. Portland Cement Concrete Paving on Jonathon Drive – Cul-De-Sac to North Main Street**

**3. Portland Cement Concrete Paving on Michigan Boulevard – Melvin Avenue to Lombard Avenue**

This is a staff recommendation.

David Houser (3050 Michigan Boulevard) – In Favor. The block needs to be redone. Only block north of the zoo on Michigan Blvd that is not concrete. In favor of concrete paving, cost is reasonable and the effect and durability is excellent.

Tom Ware (3030 Michigan Boulevard) – In Favor as long as it is concrete. Agrees with Mr. Houser that it is the only street that is not concrete north of the zoo. Wants to ensure that utilities are done before concrete is poured so there are no cuts in the new concrete in the near future.

John Rooney – Informed Mr. Pessin about the 10 day period he has to get his letter or petition to the Engineering Office. For cul-de-sac construction the City usually requires the contractor to only have construction on one side of the road at a time making sure there is still access to the properties. Although, at some point they may have to have the whole road closed, but it would not be for a long period of time. The City also has procedures in place for those that have a disability.

Ron Halverson (3027 Ruby Avenue) – In Favor. Has lived at property 18 years and has been to three public hearings for this road. In 2003 he opposed and had a petition so the road was not done. In 2013 he opposed and had a petition, but states the City wanted it done. He and his neighbors found out that not only would the road be done, but the sidewalks and trees were to be removed and parkways were to be expanded. He and his neighbors got another petition together and talked to their Alderman and Mark Yehlen and convinced the City not to do the project. Now he feels that it must be done in concrete, but wants the trees and the sidewalk to be left alone.

Warren Baugher (432 Melvin Avenue) – In Favor. Has largest footage on the block. The road is in bad shape and needs to be done in concrete.

Ronald Shumann (3019 Ruby Avenue) – In Favor. Would like concrete and agrees with Mr. Halverson about keeping the sidewalks and the trees the same.

John Rooney – Explained what a street opening from utility work is and how the City requires them to follow special specifications to restore the cut, but agrees that utility cuts help degrade the road condition. Also, when a street is reconstructed, the City contacts all utility companies to see if they would like to work on their infrastructures while the road is open to reduce the street opening permits that the utility companies will need to request in the future.

Maria Kotz (20 Sheffield Drive) – Opposed. Questioned if it is public record each family will pay as her costs seem to be much larger than that of her neighbors. Her share of the costs are over \$10,000. They are a working family and cannot afford this. Does not agree with the street assessment process as she is originally from Kenosha and has talked to people from all over the country and never heard of having to pay for a street to be reconstructed.

John Rooney – Explained the cost is the same and goes by how much frontage a homeowner has.

Westminster that was done a few years ago. He measured his frontage and it is 151 feet of which 70 feet of it is the water departments as they have a pumping station on the corner. He wants to know how much frontage he is being assessed for.

Mark Yehlen –The short side is assessed 100% of the frontage and long side is assessed at 60 feet up to the first 150 feet. He can contact the Engineering Department to find out how much footage he is being assessed.

John Rooney – Recalls receiving an email from Mr. Fawcett about the pumping station. The station is in the public right of way. There is a section that encroaches onto Mr. Fawcett's property. He spoke with the Wastewater Department and found that the station is there by prescriptive easement. Because it is an easement and the Wastewater doesn't have a title to Mr. Fawcett's property they are not sharing a cost of the construction.

Cindy Fawcett (101 Westminster Square) – Opposed. Would like to know what would be the best pavement type, because the pumping station fails so often. It seems to her that bituminous would be easier to dig up than concrete when the station does fail.

John Rooney – Pavement type does not matter when it comes to a repair. If a utility has to repair something they are responsible for restoring it to the City's specifications. Concrete is the better choice for being restored multiple times, because it is a rigid pavement that can be dowelled back together and isn't as susceptible to settling.
