Subject: Communication from Real Racine requesting to use city right-of-way for the International Cycling Classic on Friday, July 13, 2012. (Res. 12-3188)

Recommendation of the Public Works and Services Committee on 6-12-12: That Real Racine be granted permission to hold the International Cycling Classic bicycle race contingent upon providing an acceptable route and firm date by June 15, 2012, with the following stipulations:

A. A hold harmless agreement be executed and a \$62.50 processing

fee paid;

- B. A liability insurance certificate be filed prior to this event.
- C. Any overtime costs incurred by any City department be charged to the sponsor.
- D. The sponsor shall notify all abutting property owners seventy-two (72) hours in advance of this event.
- E. Sponsor shall be responsible for supplying a map of the detour route and the signing of the necessary detours for the State Highway route.
- F. The sponsor shall pay a special event fee to be determined upon approval of the route.

Further recommends that the Commissioner of Public Works, City Engineer and Chief of Police provide limited assistance, in the interest of public safety, to implement this event.

FISCAL NOTE: There will be nominal costs to various City departments, on a regular shift basis, to assist in implementing this event.

Dave Blank appeared before the Committee and explained the request. He noted it was a busy weekend as it was concurring with Salmon-A-Rama and the Iron Man Triathlon.

Alderman DeHahn noted some businesses were expressing concerns about the event hurting business.

Devin Sutherland also indicated businesses were struggling with this event and noted that last year's contest was on a Thursday, which wasn't as big of a challenge. He noted the Friday all day closure would be very difficult.

Alderman Fair also noted the impact on the businesses and thought a different day or different route could be considered.

Lt. Weitzel noted public safety is being stretched when multiple events are occurring at the same time.

Joanne Lebre, of Dover Flag and Map, also noted she was opposed to the event.

Al Stanek commented that transit operations for downtown would probably be shut down for the day because of the route that was chosen, using Main, Lake and Wisconsin Avenue.

Michael Garrison, the director of the event, indicated this would be a great exposure to downtown Racine and suggested a date change or route change could be explored.

Tim Carls also spoke regarding the event and noted he supported it and was instrumental in the planning of it and would like to see the event happen downtown.

After further discussion, a motion made by Shields, seconded by DeHahn, to approve the event subject to a possible route and date change. Passed unanimously.

Recommendation of the Public Works and Services Committee on 6-12-12: That an agreement be executed, in accordance with Wisconsin State Statute 66.0425, Privileges in Streets, to grant permission to Downtown Racine Corporation, to place decorated trunks on the sidewalks of Main Street from State Street to 7th Street, 6th Street from Main Street to Grand Avenue, from May 1, 2012 to October 1, 2012, with the stipulation that a minimum of a 5' sidewalk must be maintained at all times and that any damage to the sidewalk be repaired so as to not present a hazard to pedestrians.

Tom Eeg explained all the color options. He noted the Downtown Design Review Committee preferred the copper-colored roof as opposed to the original teal blue roof.

Alderman Kaprelian-Becker is opposed to the change in color. She believes the existing color is the brand of Racine and also noted the additional colors used in Reef Point Marina, the same color being used on the rail along the pathway system along Gaslight Pointe, the painting of the Main Street Bridge, and the letterhead the City uses.

Jim Puma also appeared before the Committee and noted the view from the lake should be considered. He noted that color roof on that building is an iconic structure for most boaters that is well recognized.

After further discussion, a motion was made by DeHahn, seconded by Weidner to approve the teal color on the roof.
