Per section 104.3, let this serve as notice of excusable delay under 108.10.3 for extra work under 104.2.2.1. Extent of delay and need for contract extension is unknown at this time. Depending on timeline for approval, procurement, fabrication and installation there is potential that bridge may not be fully in service by contract date of 4/15/2024.

Based on information provided by Ayres, it is assumed that ZTI will remove and replace two each, WT 6x13 lateral bracing. New piece will be fabricated to match existing bolt pattern based on existing piece. Steel to be painted in the same 3 coat system as already part of the contract. Bolts and other hardware needed will be procured one existing piece is removed to verify size and lengths that can not be determined ahead of time. Bolts will be tested for RoCap. Price includes all labor, equipment and materials to remove and replace, install and paint.

Steel framing member calls for removal and replacement of L4x4x3/8 member. New member will be fabricated based on existing member to match bolt patter. New member to be welded by certified welded to plate that will be masonry anchored to existing concrete. Base plate will be installed with leveling pad below and ACI anchor procedures. Price includes all labor, equipment and materials to remove and replace, install and paint.
