Amendment Scope 2009 Information Technology Consulting Services September 21, 2009

Scope of Services

This amendment includes on-call services addition to the services described in Appendix B of the original 2009 Information Technology Consulting Services contract. Examples of Tasks that will be accomplished under this amendment include:

- Sewer Atlas preparation and printing activities.
- Compilation and upload of Racine County GIS Right-of-way line, polygon, annotation layers to the City's ArcSDE.
- Query ROW layers against INFRA/PAVE pavement layers for gap/ overlap analysis.
- Query of sewer and parcel layers to identify parcels without recorded sewer easements.
- GIS coordination and assistance as requested for Cityworks integration.
- GIS assistance as requested for RouteSmart.

Project Schedule

Project work, mileposts, and deliveries will be scheduled at the time of Task definition.

Project Fee
