Pub on Wisconsin- 525 Wisconsin Ave- Unwanted Party- A named complainant (Bartender) called about a known party who was no longer allowed in the tavern. Double Vision- 3101 Douglas Ave- Man with a Gun- A named complainant (owner) called about a patron that pointed a firearm at him outside the tavern. Officers learned they were closing down the tavern when the patron refused to leave and had to be told multiple times to do so and became upset. Once the patron left the tavern they continued to cause a problem outside. The owner went outside to inform the patron to leave, at which point the patron went into their vehicle and pointed a firearm at the owner and threatened to "shoot up the bar".
