5. <u>07-0641</u> Subject: Request for sanitary sewer extension for St. Bonaventure East -

First Addition

#### **Recommendation:** Approve

The General Manager stated that the Chief Engineer reviewed the plans for a sewer extension for St. Bonaventure East and recommended approval.

Commissioner Andreasen made a motion, seconded by Commissioner Hart, to approve the request from Nielsen, Madsen & Barber, S.C. for a sanitary sewer extension for St. Bonaventure East in the Village of Sturtevant. The motion passed unanimously.

#### 10. 07-0648

**Subject:** Request to waive formal bidding for installation of handrail and award to lowest responsible bidder

#### **Recommendation:** Approve

The General Manager submitted quotes from two vendors for handrail replacement. He mentioned that even though the quotes exceeded \$25,000.00, which is the threshold for formal bidding, he felt that it was in the Wastewater Utility's best interest to waive formal bidding and accept the lowest quote. He also noted that the Capital Improvement Program listed this project at \$50,000.00 and that funds are available.

Commissioner Hart made a motion, seconded by Commissioner Anderson, to waive formal bidding for installation of an aeration basin handrail and award the job to the lowest responsible bidder, Price Erecting, in the amount of \$58,928.00. The motion passed unanimously.

### 11. <u>07-0496</u>

**Subject:** Adoption of SEWRPC Resolution on the amendment to the Racine and environs sewer service area

**Recommendation:** Approve with the exception of properties located at 5201 and 5211 Seven Mile Road remaining in the sanitary sewer service area

The General Manager recommended that a resolution be adopted regarding a Racine and Environs Sanitary Sewer Service Area Amendment with the exception of two properties along Seven Mile Road.

Commissioner Anderson made a motion, seconded by Commissioner Andreasen, to approve the adoption of a resolution regarding a proposed amendment to the sanitary sewer service area in the Village of Mt. Pleasant and the Village of Caledonia with the exception of the properties located at 5201 and 5211 Seven Mile Road remaining in the sanitary sewer service area. The motion passed on a 9-1 vote, with Commissioner DeMatthew abstaining.

#### Other Business

- A. The General Manager noted that the Town of Raymond requested to join the Racine Area Intergovernmental Sanitary Sewer Service, Revenue Sharing, Cooperation and Settlement Agreement and also expressed an interest in purchasing sewer capacity.
- B. The General Manager indicated that North Park and Crestview are now going to be regarded as "Caledonia East" and the Caledonia Utility District No. 1 will be regarded as "Caledonia West". He noted that the existing exhibits will be updated showing these changes.
- C. The General Manager indicated that Electrical Systems, Inc. was working with the Wastewater staff to review lift station logic and electrical schematics of station operation.

There being no further business, Commissioner Lui made a motion, seconded by Commissioner Staeck, to adjourn the meeting at 4:46 p.m. The motion passed unanimously.
